Message from Dr. Robert Ramsey, President of Greater Stonegate Village:

I am writing to you with some important updates on Greater Stonegate Village operations given the impact of COVID-19, as well as some resources that might be helpful to you. The good news for the day is that fewer than 2 in 10,000 Montgomery County residents have been infected with COVID-19. If we continue to practice social distancing and wash our hands frequently we will get through this!

Village Services

Greater Stonegate Village (GSV) operates as a volunteer organization. We have been successful up to this point because of the generous support of many volunteers, including those who provide rides and other services to our members. Just like all the other organizations and businesses you have probably been hearing from, we, too, are very concerned with the well-being and health of all of our members and volunteers. To this end, we are suspending all in-person activities until further notice. We will be introducing some new virtual events.

If you are truly in need of some service Greater Stonegate Village normally provides but which is not currently available, please contact us anyway. We have been working closely with the Montgomery County Village Office to learn about all ways they can help us. Rides are particularly a problem because all of our drivers are over 60. Also, it appears that our insurance does not cover us for liability with respect to COVID-19. We will do our very best to direct you to alternate options that may be available through other resources. Please give us as much notice as possible and maximum time to work with you. Senior Call Check Program

The GSV is very pleased to provide friendly callers to check in with you by phone or text regularly. To sign up, please call 240-918-7989 or email winakurs@gmail.com or me at robertramseymd@gmail.com. In addition, you can sign up for a new program offered by the Maryland Department of Aging, called Senior Call Check. The program will provide you with an automated call every day. These calls will take place within a time frame you chose. If you don't answer the first call, you will be called two additional times on the same day. If those calls go unanswered, an alternate person, you select, will be notified. This alternate could be an adult child, a neighbor, or anyone designated as a reliable contact. The alternate will be asked to check on the participant. For those who do not have an alternate or whose alternate is unresponsive, the state will call local law enforcement to conduct a wellness check. The program will also provide messages and updates regarding the COVID-19 outbreak and where to find support if you need it. Registration is required and can be completed by calling toll-free 866-50-CHECK (866-502-0560) or visiting www.aging.maryland.gov.
